

## Participating Local District (PLD) Employers July 1, 2014 Statement of Consolidated Plan Cost (a.k.a. “Green Sheets”)

We are excited to announce a change in the way PLD employer green sheets will be distributed. Beginning this year, PLD employers will receive/retrieve their green sheets via the Employer Self Service (ESS) portal through [www.MainePERS.org](http://www.MainePERS.org). This is a more effective way to distribute the reports and a more secure and convenient way for employers to access the information.

To get a feel for the new process, we’ve loaded the July 1, 2013 green sheet documents at your specific employer location and ask that you take a look to get familiar with the process of accessing the report. You will find the report in the Review Payroll Reports, Billing History & Payments section of ESS and clicking on the Documents tab.
