CONFIDENTIALITY ELECTION FORM HOME CONTACT INFORMATION

MainePERS takes the responsibility of keeping your personal information confidential seriously. By law, we are required to keep the home contact information of our members and benefit recipients confidential. "Home contact information" means your home address, home telephone number, home fax number and home e-mail address.

There is one exception. Unless you specifically indicate otherwise, we will provide your home address only to certain nonprofit public sector retiree organizations for membership recruiting purposes. If you do not want MainePERS to release your home address even in this limited circumstance, complete and return this form, as instructed below.

If you do not complete and return this form to MainePERS, we will keep your home contact information confidential, as provided by law, with this one exception. Even if you do not authorize the release of your home address to qualified retiree organizations, you may want to contact specific entities you wish to have your home contact information. The second page of this form provides a list of organizations that frequently request this type of information from MainePERS. This election will remain in effect unless revoked by me and any revocation will be effective only after it is received at the Retirement System. I understand that I may revoke this election at any time by submitting a written revocation or new election by mail or in person to the following address:
